At the outset I would like to convey words of appreciation to your organization for your continued participation in the skill development program for Graduate and Diploma Engineers under The Apprentices (Amendment) Act, 1973 & 2014.

You will agree that the growth of industries across all the sectors viz. manufacturing, services etc. is highly dependent on qualified technically skilled manpower. The human resource having engineering qualification forms the top and middle level management in any organization. Such resources is also required to be skilled appropriately time to time to familiarize with the technological advancement taking place very rapidly.
