


1. Definitions:


- a. For the purposes of this agreement " 1st " institution shall mean BOARD OF PRACTICAL TRAINING " (EASTERN REGION), KOLKATA (BOPTER), and " 2nd " institutions shall mean JIS GROUP.
- b. 1st Institute shall extend the support of conducting the orientation program through online or offline mode for the final year and passed out diploma/graduate students of 2nd Institute for their enrolment in the apprenticeship portal, so as to make them aware of about NAT Scheme of the Central Government including stipend policy, entry/exit policy in apprenticeship etc.


- c. 2nd Institute shall ensure the students of the final year students are enrolled in ACJF portal and pass out graduate/diploma students are enrolled in NATS portal for apprenticeship training every year, provide the space and other logistic support for conducting the awareness cum motivational workshop for the students.
2. **Purpose of the Agreement:** The general purpose of this agreement is to establish a relationship and cooperation between the two participating institutions to develop the prospective skill of the pass out diploma/graduates so that they become a skilled and more employable human resource for industry or organizations.
3. **Responsibilities of Participating Institutions and Students:**
- a. "1st" shall take the responsibility to support the awareness program for final year and pass out diploma/graduate students of 2nd Institution by means of conduct of seminar or workshop both online and offline mode.
- b. "1st" Institution shall take the responsibility to help the final year students for their enrolment process in AEJF portal and pass out diploma/graduate students of "2nd institute" for their enrolment process in NATS portal. (nats.education.gov.in).
- c. "2nd" Institute shall take the responsibility to select the prospective final year and pass out diploma/graduate students, for awareness building program in form of seminar or conference.
- d. 2nd" Institute shall provide the logistic support like space, etc, to conduct such workshop or seminar or Apprenticeship cum Job Fair as requested by 1st institute.
- e. "2nd" Institute shall provide a link of website of "1st" Institute on the prominent place on their website.
- f. "2nd" Institute shall attach promos of BOPT(ER) and its activities free of cost on the "2nd" official magazine (Hard Copy or Digital Copy).
- g. RAD participation By Principal / Head of the institution of the "2nd" should be ensured.
- h. 2nd Institute will participate in 'GADP" through maximum number of final year students.

5. **Notices:** Any notice or other communication under this agreement shall be given in writing and delivered by hand, sent by post, facsimiled transmission, or e-mail.
6. **Signatures:** This agreement constitutes in principle to proceed and work out more detailed modalities to operationalize the same between the parties. No amendments consent or waiver of terms of this agreement shall bind either party unless in writing or signed by both parties.
